The Nilles e-commerce platform offers a similar online service for higher volume customers with more complex label needs on a roll, in special sizes and materials. Their customer base typically includes breweries, cosmetic brands and other product manufacturers.

Avery's Mark Cooper continued: "By bringing the Nilles e-commerce service and the Avery offering together we have the opportunity to meet the labelling needs of a range of different markets, from home and office users right through to larger businesses with complex merchandising requirements. Together with our specialist online design software and e-

commerce tools, we see this as the next step towards offering the most comprehensive range of labelling, packaging and branding options to suit a wide variety of business needs."

Globally, the expectation is that both of these new capabilities will be available on a world-wide basis using either the Avery brand or one of the many domain names owned by Nilles, which include www.label.co.uk and www.etikett.de.
